VENDOR INFO

We now are no longer under the Event/Gathering category. We now fall under the ALSO KNOWN AS "FARMERS MARKETS" OR "COMMUNITY MARKETS" AND HEREINAFTER REFERRED TO AS A "MARKET" OR "MARKETS" as essential service. Food Vendors are a priority as they are "essential service" for this reason I was able to continue this year. Artisans will be allowed as well. The main point is to remember we are a Market & not an Event. We are still Artisans Showcase, but we are putting on a Community Holiday Market.

The onus is on the vendor to ensure appropriate compliances and approvals have been obtained prior to selling their goods, including all required permits. (example Insurance, Food Safe)

We will be following the guidelines of the Farmers/Community Markets where you as Vendors will be allowed to be part of your booth during the Market. You will set up your booth and remain during the show to be able to talk with your customers. All Safety Protocols must be in place for both you & your Customers. We will be a Shop & Go Market; we must limit the time of socializing with customers. Social Distancing must always be in place along with Sanitizer for both yourself & the customer. Booths will be setup with Social Distancing between each Vendor as well. You will not be allowed to sell unless you are following all the guidelines of Safety Protocols. No Sampling will be allowed. The aisles will be one-way traffic along with an entrance & exit point. Handwashing Station will be setup at the Entrance door as well as the exit door.
